❖ Introduction of New Middle School Counselor – Julie DeWolf

Superintendent Powers introduced the new middle school counselor, Julie DeWolf who was formerly a school counselor at Greece Central Schools and lives in Port Byron.

❖ College & Career Day Update – Nina Darnell & Hannah Cognetti

Mrs. Darnell and Ms. Cognetti gave the board an overview of many college and career preparations going on with students in the middle and high school. On November 17, 2017, they coordinated a successful college and career day with 33 presenters. Presenters commented on how engaged and well-behaved the Union Springs students are.

In addition to the college and career day, students (and parents) are involved in the some of the following:

Solution Elementary Counselor Update – Hannah Russell

Hannah Russell transferred from the middle school to the elementary school for the 2017-18 school year. She started the school year with a core group of students of approximately 13-15 students and to date that number has doubled.

She gave the board hand-outs of the state counseling model in which school counselors follow, along with an overview of what she is presently working on. The majority of her work is on a personal/social level due to the age of the students she is counseling. She is also working with groups on friendship and social skills. Ms. Russell currently has weekly intervention meetings at the elementary level. In the near future she hopes to meet with the middle and high school counselors to schedule regular meetings for discussion around working collaboratively to ensure students are ready for the higher grade levels and make a smooth transition.

❖ Discussion - Summer 2019 - Costa Rica Trip − Chuck Walker

The board had a brief discussion about the Costa Rica trip. While they approve of the trip and its educational opportunities for students, it is disheartening that we are living in a world where we have to worry about traveling abroad and safety.

Superintendent Powers

The Board discussed and signed a letter to be sent to the Town of Aurelius regarding the error made by the Town Assessor that will impact the district heavily. Many of the board members plan to attend the next Town of Aurelius Board Meeting, which is on December 14, 2017, to speak out about their concerns. Superintendent Powers will bring financial impacts to the board in January for discussion, along with the Aurelius tax error that will have a substantial financial impact on the district.

He also apprised the board members about an inspection of the rooftop unit at the bus garage, which detected carbon monoxide leakage into the bus garage. The repairs will begin immediately and the cost will be approximately \$8,000.
